SECRETARY'S REPORT

- Jill is thankful for the new snow shovel. Snow was plowed after yesterday's snow.
- Jill declared success repairing computer #2.
- ALL-RIGHT SIGNS called to inform us that Verizon is kicking devices like our outdoor sign off their 3G network and forcing us into 5G. We have no choice but to replace the modem which will cost \$825.
- The board discussed the need for the ONE WAY DO NOT ENTER sign for the flow of traffic moving around the building to access the Book Drop.

Saller moved to place the order for the ONE WAY DO NOT ENTER sign, seconded by Wehling.

- The board members read Jill's letter of thanks to Kevin Walsh, of **Children's Plus** for their generosity. The company donated \$4,398.56 for furniture and other supplies for the Children's section in our new Meeting Room. Everyone signed her letter.
- A representative for the **2020 Census** met with Jill asking that we advertise the need for Census workers. Workers will earn \$25 hr. Jill would also like to offer our services to assist people who need help filling out their census form on a computer. Our Jan/Feb newsletter will have a blurb encouraging folks to fill out their upcoming census forms. Our per-capita grant, the number of Congressional seats and \$675 billion in federal monies are dependent on the census count.
- The Chicago Regional Carpenter's Union and the Chicago Laborers District Council Labor-Management Cooperation Committee have submitted **FOIA** requests for prevailing wage certified payroll for our building project. Jill is on it.
- Board looked over Jill's first draft of possible Meeting Room policies. She will make a short list to be discussed next month.
