Meeting began with the Pledge of Allegiance.

TRUSTEE ROLL CALL: Biery, present; Bunte, present; Czarnecki, present; Dean, present; Saller, absent; Skold, present; Wehling, present.

Jill Grosso & Vicki Squier were also present.

SECRETARY'S REPORT

Minutes of September 15, 2015 were reviewed. Skold moved to accept minutes as presented, seconded by Wehling.

Biery, yes; Bunte, yes; Czarnecki, abstain; Dean, yes; Saller,; Skold, yes; Wehling, yes. Motion passed.

TREASURER'S REPORT

The Treasurer's report was presented by Gwen. Finances are sound. Shirley asked about the refund from Grinnell, Gwen & Beverly assured us that this occurs each year.

Skold moved to approve Treasurer's report as presented, seconded by Czarnecki.

- "Making new Books Non-Holdable by Non-patrons" project is completed.
- Children and Adult programs have been successful. "Memories of WWII"

program had approximately 40 guests, many new faces.

- Upcoming programs: Galapagos Islands, Nov.19; Crochet class for girls12-18; *Star Wars* themed program is in the works.
- Date to expect Per-capita grant was moved to Jan. 15,2016. Jill is skeptical of this happening, considering the state's financial distress.
- Jill has experienced problems with Chase Bank, in an effort to get the library's credit card. More on that later.
- A student taking a library management class has been interviewing Jill for her class.
- Jill requested vacation time, 11/30-12/4.
- Discussion was held about news feeds on our Facebook account which will advertise upcoming events and other important notices. Board agrees it would be wise to give it a trial period, good PR.

Shirley expressed concern over dwindling number of patrons & asked board to think about new ideas for Community outreach for next month. Jill believes many patrons are going to Crete.

Specialty classes, not necessarily college courses, can be made available to enhance their working experience, paid for by the library. \$1,000.00 has been set aside each year for staff education, & has never been used. Gwen suggests we set up 4 options, & present them to the staff.
